Any deviation of the above, action will be initiated against the management of the school and informed that the Recognition now accorded will be withdrawn without assigning any reasons thereof.

Further, the managing committee of the school is requested to fulfil all requirements to cope up with the needs of the institution at the latest before submitting the application for Renewal of Recognition for the year 2030-31.
